PUBLIC ART REMOVED

Four large, metal "box" sculptures by Artist Catherine Lee of Wimberly were removed from Mahncke Park on June 7. The sculptures were exhibited in the east end of Mahncke Park near N. New Braunfels Avenue since March 2019, per an agreement between the Parks Dept. and Tres Centurias Foundation, a local non-profit entity. The Foundation paid the costs of installing and removing the sculptures, their concrete pads, and the temporary lighting.

Three granite stone sculptures by the late artist Jesus Moroles in the west portion of Mahncke Park were installed in February 2020. They will remain in place for the foreseeable future.

The fountain in Mahncke Park is operating again. City Councilman McKee-Rodriguez' office worked with the Parks Dept. to expedite repairs. A variance to SA Water System's watering restrictions was granted authorizing the fountain's operations.

Anna Marie Mahncke Deutz donated the fountain in 1964 to the memory of her father, Ludwig Mahncke.

BOTANICAL GARDEN OFFERS N'HOOD DISCOUNT

As a result of a recent meeting in which area residents expressed the need for more affordable annual membership fees, the Botanical Garden announced last month a 30% discount on annual memberships for Mahncke Park residents. The discount means that a regular \$75 membership will be \$52.50, a regular \$65 senior membership will drop to \$45.50, and a dual membership will go from \$95 to \$66.50. SAVE \$ TO RIDE THE RAILS IN BRACKENRIDGE PARK

A minature train has operated in Brackenridge Park since 1956, entertaining adults and kiddos, visitors and locals. Known now as the Zoo Train, there are two new, different locomotives with new, covered passenger cars, which are less cramped than earlier models.

A \$24 annual pass was recently announced. If you ride twice or more monthly, the annual pass will enable savings over the standard \$3.50 per ride price. The train runs during zoo hours, 9am - 5pm daily, except Saturday when the hours are 9am - 7pm. Note that riders under 14 must be accompanied by an adult, but judging from the smiling adults seen on the trains that will not be a hardship.

BRACKENRIDGE PARK: NEW LEADER

The Brackenridge Park Conservancy has hired Chris Maitre as its new CEO. He is the former operating officer of the New Orleans City Park Conservancy. Maitre replaces Interim CEO and former San Antonio City Manager Terry Brechtel.

NEIGHBORHOOD HISTORY: TRAIN ROBBERY

On Saturday afternoon, July 18, 1970, the Brackenridge Park train was robbed at gunpoint by two masked gunmen. Perhaps inspired by that year's popular movie "Butch Cassidy & the Sundance Kid" which featured men on horseback robbing trains, the two men rented horses at Brackenridge Stables, asking 13 year-old Lana Sue Fincke for directions to the train tunnel near Avenue B. (Lana Sue now lives in Mahncke Park). The men rode to the tunnel, one put on a red & blue ski mask – the other pulled a woman's blue stocking over his head, and when the train exited the tunnel they stepped onto the track, pointed a .22 caliber pistol at the train's engineer, and ordered him to stop the train.

The robbers moved down the train taking about \$300 cash, credit cards, car keys, cameras, checkbooks, and purses from the passengers. Several believed the robbery was a joke. Some managed to hide their valuables. Before reaching the end of the train, the robbers noticed the engineer speaking on his walkietalkie – they ran to their getaway car, a red Ford Mustang.

Ten days later, Paul E. Smith and James R. Brown, ages 21 and 24, were arrested for Robbery by Assault with Firearms, following a tip to SAPD from an acquaintance of both men. Smith and Brown were US Army non-commissioned officers stationed at Ft. Sam Houston. They lived in the Park Terrace Apartments, 106 Chinaberry (the six building complex that once stood south of Mulberry Ave. and east of the presentday Doseum parking lot). Both men pleaded guilty to the train robbery, and Smith also pleaded guilty to robbing the Lone Star Ice House at 3819 West Avenue on July 13, 1970. The District Attorney's Office recommended minimum sentences and Judge Preston Dial concurred, sentencing both men in 1971 to serve no less than 5 and no more than 10 years in the Texas Dept. of Corrections prison system.

Paul E. Smith was in prison from February 1971 until July 1973. Following an unsuccessful appeal, James R. Brown served from May 1972 until February 1975.

NOTE 1: After the train robbery but prior to going to prison, James R. Brown married and lived at 443 Eleanor Ave.

NOTE 2: Paul E. Smith died April 29, 2010 from natural causes at age 61.
